To receive payment for more than one purchase or exchange and up to fifteen (15) transactions, you must send copies of your proof(s) of purchase for each cylinder purchased or exchanged. If you do not have proof of purchase, please nonetheless complete this form to the best of your recollection but note that your settlement recovery will be limited to payment for one (1) transaction.

CATEGORY A CLAIM--REQUIRES PROOF OF PURCHASE OR EXCHANGE

As part of your claim, to receive a payment for up to fifteen (15) transactions, or a maximum of \$75.00, you ***must*** provide proof of each transaction.

Any of the following will be considered acceptable as proof of payment for an AmeriGas cylinder so long as it reflects the purchase or exchange of an AmeriGas Propane cylinder as opposed to some other product or service:

- (3) Records from the store or from the self serve station at which you purchased or exchanged the tank; or
- (4) Any other verifiable and contemporaneous documentation of your transaction.
